



2026 Woodford Trailers HSA Speed Championship (incorporating the pre 1994 Formula Ford Challenge)

1. SPORTING REGULATIONS - GENERAL

1.1 Title & Jurisdiction:

The 2026 Woodford Trailers HSA Speed Championship, incorporating the pre 1994 Formula Ford Challenge, is organised and administered by the Hillclimb & Sprint Association (HSA) in accordance with the National Competition Rules (NCR) of the Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA) and these Championship Regulations.

1.3 Competitor Eligibility:

1.3.1 Entrants must be fully paid-up valid membership card holding members of the HSA and be in possession of a current Motorsport UK Entrants Licences.

1.3.2 Drivers and Entrant/Drivers must be fully paid-up valid membership card holding members of the HSA, be Registered for the Championship and be in possession of a current Competition RS Interclub Status Licence, as a minimum.

A competitor shall not take time off school to participate in motor sport without the prior written approval of their school. If participation in the Championship requires absence from school, Drivers in full time school education are required to have the approval of their head teacher and a letter stating such approval from their school in order to fulfil registration for the Championship.

1.3.3 All necessary documentation must be presented for checking at all rounds when signing-on.

1.3.4. The Pre 1994 Formula Ford Challenge will be open to competitors in cars eligible for Class J1 and who are members of the Pre 1994 Formula Ford Register

1.4 Registration:

- 1.4.1 Competitors can register and pay either on-line at www.hillclimbandsprint.co.uk or by completing a registration form (obtainable either from the web site or by post from the Championship Co-ordinator) and returning it as instructed.
- 1.4.2 £35 per class entered, plus the HSA membership fee if the entrant/driver is not already an HSA member.
- 1.4.3 Competitors must register in the appropriate Championship class for their vehicle(s) at least seven days prior to the first event in which they intend to compete in that vehicle.
- 1.4.4 Competitors for the Pre 1994 Formula Ford Challenge may register in one of two ways:
 - 1.4.4.1 Register in the 2026 HSA Speed Championship in Class J1
 - 1.4.4.2 Register with the Championship Coordinator as a Pre 1994 Formula Ford Challenge competitor, have paid the fee of £7 and be in possession of a current Competition RS Interclub status licence as a minimum. Competitors registered under 1.4.4.2 will not be eligible to compete in any other events in the HSA Speed Championship beyond the 6 events listed in 1.5 below.

1.6 Scoring:

1.6.1 In order to qualify for points in an event, registered competitors must be classified in the official results as a starter by completing at least one timed competitive run.

Scoring will be based on each competitor's fastest time set in any of the complete (i.e. where all competitors were able to take their run) competition runs offered by the organiser. If not all competitors at the event are given the opportunity to make at least one competition run and/or the organisers do not publish any official results, then the event will not qualify as a Championship round.

Should an event take place over two days, which constitute more than one Championship qualifying round, then all competition runs (i.e. excluding those designated as practice runs) offered by the organiser each day will be included for scoring purposes.

Points will be awarded for every registered Championship competitor at each qualifying event based on each competitor's best time (excluding practice runs) in relation to the appropriate Championship class record standing at the commencement of the event as follows:

- 18 points for breaking the class record by more than 3%
- 17 points for breaking the class record by more than 2.5% and up to 3%
- 16 points for breaking the class record by more than 2% and up to 2.5%
- 15 points for breaking the class record by more than 1.5% and up to 2%
- 14 points for breaking the class record by more than 1% and up to 1.5%
- 13 points for breaking the class record by more than 0.5% and up to 1%
- 12 points for breaking the class record by up to 0.5%
- 11 points for a time up to 1% slower than the class record
- 10 points for a time more than 1% and up to 2% slower than the class record
- 9 points for a time more than 2% and up to 3% slower than the class record
- 8 points for a time more than 3% and up to 4% slower than the class record
- 7 points for a time more than 4% and up to 5% slower than the class record
- 6 points for a time more than 5% and up to 7% slower than the class record
- 5 points for a time more than 7% and up to 9% slower than the class record
- 4 points for a time more than 9% and up to 11% slower than the class record
- 3 points for a time more than 11% and up to 13% slower than the class record
- 2 points for a time more than 13% and up to 15% slower than the class record
- 1 point for a time more than 15% slower than the class record

Where a Championship class record does not exist at the commencement of a qualifying event, the fastest time recorded by a registered Championship competitor in that class at the event will be deemed the existing class record.

Thus, the competitor who records the fastest time and establishes a new record will score 12 points and the remaining competitors will score additional points in the following manner:

11 points for a time up to 1% slower than the class record
10 points for a time more than 1% and up to 2% slower than the class record
9 points for a time more than 2% and up to 3% slower than the class record
8 points for a time more than 3% and up to 4% slower than the class record
7 points for a time more than 4% and up to 5% slower than the class record
6 points for a time more than 5% and up to 7% slower than the class record
5 points for a time more than 7% and up to 9% slower than the class record
4 points for a time more than 9% and up to 11% slower than the class record
3 points for a time more than 11% and up to 13% slower than the class record
2 points for a time more than 13% and up to 15% slower than the class record
1 point for a time more than 15% slower than the class record

Competitors will be allowed to accumulate points gained in different cars, registered on their entry form, or notified to the Championship co-ordinator within three days of the event if different, within the same Championship class.

A Competitor will be allowed to enter a different car in more than one Championship class by making a separate entry (with a Championship entry fee payable) for each class and will accumulate points separately in each Championship class but may only qualify for an award in one class which will be that with the highest score.

No competitor may enter the Championship in the same car in more than one Championship class and any tie break that may be applied.

Points gained in up to nine of the qualifying events will count towards the Championship scoring and any tie break that may be applied. Should a competitor score in more than nine rounds the lowest scores will be dropped.

Scoring records for the Championship will be maintained by the Championship Co-ordinator, Mrs Pat Toulmin. Updated results will be published on the HSA web site www.hillclimbandsprint.co.uk as soon as possible after each event.

Event organisers are expected to supply published results of the event to the Championship Co-ordinator by post, email or download within seven days of the event. Periodic bulletins of intermediate marking will be advised via the website www.hillclimbandsprint.co.uk.

The final results will be published on the HSA's web site as soon as practicable at the conclusion of the Championship.

1.6.2 In the event of a tie between two or more competitors at the end of the Championship the following tiebreak procedure will be adopted in the sequence shown, until a result is obtained:

- (a) The number of 18-point scores will be counted and the competitor with the highest number will be declared the winner. If there is still a tie, the number of 17-point scores will be counted and so on until a winner is identified.
- (b) If two or more competitors are still tied, then the average percentage by which each competitor broke (or fell short of) the class record at each event will be calculated and the competitor with the best score will be declared the winner.
- (c) Should none of these methods be effective, the Championship Organisers will specify the method of solution.

1.6.3 Scoring for Pre 1994 Formula Ford Challenge

1.6.3.1 There will be 6 events with the first two competition runs counting as two rounds at each event. The best 8 rounds of 12 will count. In the event that fewer than 12 rounds take place, the number of qualifying rounds will reduce as follows:

12 to 11 rounds then 8 to count

10 to 9 rounds then 7 to count

8 to 7 rounds then 6 to count

Anything less than 7 rounds then all rounds count

1.6.3.2 The winner of each round will receive 100 points and the remaining competitors will receive the inverse % off winner's time. In order to qualify as a round, the run has to be completed in full and an official time given by the event organisers.

Example of scoring per round:

Competitor A is fastest on a round with a time of 60.99 and scores 100 points

Competitor B has a time on the same round of 64.37

Competitor B Score = $100 \times (1 + (A - B) / A) = 94.46$

1.6.3.3 Note that no points will be scored by competitors registered under cl 1.4.4.2 in the HSA Speed Championship and no new HSA records will be recognised if set by these competitors.

1.6.4 Championship Points Appeal in accordance with Chapter 2 Appendix 5 Art 2 of the Motorsport UK National Competition Rules

Any query regarding the results must be made to the Championship Co-ordinator within 7 days of the results being published (on the web site), after which no alterations to the scores will be considered except for cases taken to the National Court.

1.6.5. Event Penalties – Not Applicable



1.7 Awards:

1.7.1 At the conclusion of the Championship, the Championship awards will be presented as follows. Registered Competitors must gain points in at least three qualifying rounds to be eligible for all awards.

(a) Overall positions:

1st Place: The HSA Championship Trophy (to be held for 12 months), a free entry to an HSA Championship event in 2027 and a trophy.

2nd Place: A free entry to an HSA organised event in 2027 and a trophy

3rd Place: A free entry into the 2027 HSA Speed Championship and a trophy

4th Place: A trophy

5th Place: A trophy

(b) Class positions:

1st Place: A trophy subject to 1 entry in the class

2nd Place: A trophy subject to 5 entries in the class

3rd Place: A trophy subject to 10 entries in the class

1.7.2 The Championship "Competitor of the Year": The HSA 'Competitor of the Year' shield to be held for 12 months and a trophy.

The Peter Stevens Memorial Cup for the competitor with the highest score from up to 4, but not less than three qualifying rounds: The Peter Stevens memorial cup (to be held for 12 months) and a trophy.

The Russ Ward trophy (to be held for 12 months) will be awarded to the Organising Club of the 'best' Championship round as determined by the HSA Committee.

The Paul Squires Memorial trophy will be awarded to the most meritorious performance in a racing car up to 1100cc as determined by the Championship Organisers (to be held for 12 months).

The HSA Dual Drive Shield, or Tyre Warmers Trophy (to be held for 12 months) will be presented to the drivers with the highest combined overall score where the competitors share the same car in the same class, and a trophy each.

The HSA Novice Trophy awarded to the competitor scoring the most points in their first year of holding a competition licence.



The HSA under 25s Trophy awarded to the competitor scoring the greatest number of points who was under 25 years of age on the date of the first championship round.

An award to the driver of the highest scoring car in Class J1 which was built up to 31 December 1973, provided he or she is not the overall winner of Class J1.

The overall winner of the Pre 1994 Formula Ford Challenge will receive the Pre 1994 Formula Ford Register Trophy to be held for 12 months. Awards will also be made to the second and third placed competitors.

The Clive Wooster Memorial Trophy for highest points scorer from classes F1 and F2.

The Championship Awards Presentation will be held in November 2026. Details will be published nearer the time on the HSA website.

2. SPORTING REGULATIONS - JUDICIAL PROCEDURES

2.1 Rounds: In accordance with Chapter 2 of the Motorsport UK 2026 National Competition Rules, and the Supplementary Regulations of the qualifying round

2.2 Championship: In accordance with Chapter 2 the of Motorsport UK 2026 National Competition Rules, and these Regulations

3. SPECIFIC CHAMPIONSHIP REGULATIONS

3.1 By registering for the Championship all competitors and their associates commit to positively promote and demonstrate the Motorsport UK's Respect Code which is appended to these regulations (Appendix 1)

3.1.1. Where any reports of disrespectful conduct are judged to be well founded the Championship organisers may issue warnings or require remedial actions and/or report the matter to the Championship Stewards who may impose appropriate penalties which can include loss of Championship points and/or race bans through to Championship Expulsion and referral to Motorsport UK.

3.1.2. It is imperative that we promote the safety and wellbeing of young people and adults at risk. In addition to this all participants must be aware of their behaviour and conduct at all times, and abusive language and harmful behaviour will not be tolerated. Any such incidents must be reported to the Championship Coordinator and/or Safeguarding Officer who will also relay the report Motorsport UK. Details of the Motorsport UK Policies and Guidelines are available at www.motorsportuk.org/resource-centre by selecting Policies and Guidelines.

3.2 Due to both safety and environmental concerns, vehicles must not be left unattended under any circumstances when the engine is running.



4. TECHNICAL REGULATIONS

- 4.1 To be eligible for the Championship all vehicles must comply with the Common Regulations and Specific Regulations for Standard Cars, Road Cars, Modified Cars, Sports Libre Cars and Racing Cars included in the Motorsport UK 2026 National Competition Rules. Chapter 14, Specific Regulations for Sprint, Hill Climbs and Hot Lap Challenge.

To be eligible for championship points or for the Pre 1994 Formula Ford Challenge, competing vehicles must carry the championship decals provided, in accordance with the advertising rules set out in Ch. 16 App. 1 Art. 9 of the Motorsport UK 2026 National Competition Rules. Where the vehicle bodywork does not allow compliance with NCR Ch 6 App.1 Art. 9 then the championship decals should be displayed in as clear and visible position as possible.

Each qualifying event will run under its own Supplementary Regulations and championship competitors will be bound by these SRs, Motorsport UK National Competition Rules and these Championship Regulations

Competitors in the individual qualifying events will take part in the appropriate class for their vehicle for the awards offered at that event. Where classes at an event do not match the HSA Championship classes the results will be re-structured into the HSA Championship classes for scoring purposes

- 4.2 For the purposes of Championship scoring, vehicles will be divided into the following classes:

Standard Cars

- S1 As per Ch.14 App. 4 Art. 13
- S2 Juniors

Road Cars as per Ch.14 App. 4 Art. 14

- A1 Road Cars Series Production up to 1400cc
- A2 Road Cars Series Production over 1400cc & up to 2000cc
- A3 Road Cars Series Production 2WD over 2000cc
- A4 Road Cars Series Production 4-Wheel Drive over 2000cc

Road Cars Specialist Production

- B1 Road Cars Specialist Production cars up to 1700cc
- B2 Road Cars Specialist Production cars over 1700cc

Modified Cars as per Ch.14 App. 4 Art. 15

- C1 Modified Cars Series Production up to 1400cc
- C2 Modified Cars Series Production over 1400cc & up to 2000cc
- C3 Modified Cars Series Production over 2000cc

Sports Libre Cars

K Racing Cars over 1600cc & up to 2000cc

L Racing Cars over 2000cc

Notes:

Tyres on vehicles in Classes S1 must comply with List 1A (Ch. 8 App. 4) appearing in the Motorsport UK 2026 National Competition Rules.

Class S2 is open to competitors defined in the Ch.14 App. 2 Art.1.9 -1.11 for new drivers aged 14 to 16 competing in a Standard Car of no more than 110 bhp until the end of the year of their 16th birthday. NOTE: Some championship rounds may not run classes for Junior competitors, and these have been indicated with an asterisk.

Tyres on vehicles in Classes A1, A2, A3, A4 B1 and B2 must comply with List 1A and List 1B (Section L permitted tyres) appearing in the Motorsport UK 2026 National Competition Rules List 1A and 1B NCR Cha. 8 App.4, but to include radial construction tyres only.

All vehicles in Road Car classes must be taxed and, where relevant, hold a current MOT test certificate.

Vehicles with spaceframe chassis are excluded from Classes C1, C2 and C3.

Formula Ford 1600 vehicles in Class J1 must comply with Pre 94 Formula Ford Register Guidance Notes – see Appendix 2.



Eligibility issues will be reviewed by the Eligibility Scrutineer. To avoid eligibility problems, it is advisable for all cars (except Road Car categories) to carry a Motorsport UK Vehicle Passport. In the event of an unresolved eligibility problem, the driver of the car concerned may be asked to produce a manufacturer's catalogue within four weeks of the event in question to substantiate any queried modification/specification and allow the championship points to stand.

The Championship organisers reserve the right to merge or sub-divide classes at the commencement of the Championship, should entries justify this.

4.3 Drivers must comply with Ch.14 App.2 Art.4 of the Motorsport UK 2026 National Competition Rules. at all times.

5. ENVIRONMENTAL CONCERNS

Motorsport UK are exceedingly concerned of the impact of single-use plastic tyre wrapping and use of these plastic wraps is banned. Please refer to **Ch. 4 App. 3 Art. 1.3** of the Motorsport UK 2026 National Competition Rules
